#### EOD 2018

- Effective for all cases diagnosed 1/1/2018 and forward
- CS schemas used as the base for EOD development
  - CS Schemas combined when possible
- Additional schemas developed based on AJCC 8<sup>th</sup> edition

## Summary Stage 2018

- Effective for all cases diagnosed 1/1/2018 and forward
- Summary Stage chapters updated based on AJCC 6<sup>th</sup>, 7<sup>th</sup>, and 8<sup>th</sup> edition
- Chapters modified to be as compatible with SS2000 as possible

## Grade in 2018

- Effective for all cases diagnosed 1/1/2018 and forward
- 3 Grade fields Grade Clinical, Grade Pathological, Grade Post Therapy
- Grade values are site specific
  - Priority order of codes are noted
  - Schemas with specialized grading systems usually have old values (Well, Moderately, Poorly Differentiated, Undifferentiated) if preferred schema is not noted in medical records

## SSDIs for 2018

- Site Specific Factors (SSFs) reused slots, 3 digit codes
- Site Specific Data Items (SSDIs)
  - Each item has its own field
  - Length and valid values of field vary by need
  - Decimals are used for Lab Values
  - Valid value list in alignment with CAP protocols where appropriate

  - Grade Manual, v1.4
  - Appendix A, v1.4
  - Version 1.4 Changes for SSDI and Grade Manuals

#### Version 1.5

- To be published early 2019
- Will incorporate changes based on questions/issues found since release of Version 1.4
  - Known issues for EOD and Summary Stage Version 1.5 will be posted on the SEER website

## SSFs and SSDIs-SSDI Recode

- Developing SSDI recode so that data can be viewed over time
  - Original SSF data and incoming original SSDI data will still be available
  - Allows SEER\*Stat user to view SSF/SSDI over time (especially the 2017 to 2018 change) without having to figure out how make the data comparable
- Draft of the SSDI recodes have been completed (under review)
  - Next step is to send to IMS to "convert" SSF data and make sure all cases are accounted for
- To be available in SEER\*Stat sometime in late 2019

## 2019 Reliability Study

- Testing of EOD, SS2018, SSDIs, Grade
  - Testing open March 1, 2019-April 15, 2019
  - 10 schemas
  - Expert Review Panel
    - Jennifer Ruhl (SEER) and Carmela Groves (Westat)
    - Each case will be reviewed by an additional 2 SEER registrars for preferred answers and rationale
    - Adjudication done as needed
